In accordance with Regulations 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), notice is hereby given that the Harborough Local Plan 2011 – 2031, a development plan document (DPD), was formally adopted by Harborough District Council on 30 April 2019.

The Harborough Local Plan 2011 – 2031 replaces the Harborough District Local Development Plan Core Strategy 2006-2028 (adopted in 2011) and the Harborough District Local Plan (adopted in 2001) (retained policies).

The Harborough Local Plan was subject to examination by an independent inspector appointed by the Secretary of State, Jonathan Bore BA MRTPI DipUD, who issued his report on 8 April 2019. The report concluded that, subject to Main Modifications, the Local Plan was legally compliant and sound pursuant to Section 23(3) of the Planning and Compulsory Purchase Act 2004. The adopted, final version of the Local Plan includes all the Main Modifications recommended by the Inspector.

Any person aggrieved by the Harborough Local Plan 2011-2031 may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that the Local Plan is not within the appropriate powers conferred by Part 2 of the Planning and Compulsory Purchase Act and /or a

procedural requirement has not been complied with. Any such application must be made by no later than 12th June 2019 (this represents a period of six weeks beginning with the day after the date on which the Local Plan was adopted).
