Saddington Parish Neighbourhood Forum has a written constitution as detailed in section 3.

The purpose of Saddington Parish Neighbourhood Forum is:

- To prepare a Neighbourhood Plan for the Saddington Parish Neighbourhood Area;
- To promote or improve the social, economic and environmental well-being of the Saddington Parish Neighbourhood Area;
- Any other appropriate purpose agreed by the Forum.

# 6. Membership of proposed Neighbourhood Forum

A minimum of 21 members is required, each of whom must live, work or carry out business in the neighbourhood area, or be an elected member (whose area falls within the neighbourhood area).

The Neighbourhood Planning Regulations 2012 require a Neighbourhood Forum to comprise a representative cross section of the Neighbourhood Area.
