Play is of fundamental importance for children and young people's health and well-being, their relationships, development and learning. The UN convention on the rights of a child gives all children the right to rest and leisure; to engage in the appropriate play and recreational activities. In 2006 the Big Lottery Fund launched the £155 million Children's Play initiative based on the recommendations of the 2004 play review Getting Serious About Play. Harborough District Council have been provisionally allocated £200,000 for improving play within the District, but with the condition that a Play Strategy and associated action plan is in place, and has been adopted by the local authority.
