PUBLIC PATH EXTINGUISHMENT ORDER 2021

On 3rd February 2022 Leicestershire County Council confirmed the above Order made under Section 118 of the Highways Act 1980.

The effect of the Order as confirmed (without modification) is to extinguish the part of Public Footpath X31 (part) in the Parish of Misterton with Walcote and the District of Harborough, shown by a bold continuous line on Plan No. 2558 annexed hereto, which extends from point "A" on the plan, situate at its western-most junction with the A4304 Lutterworth Road at Grid Reference 45592 28352, in generally east-south-easterly and east-north-easterly directions following the southern boundary of the A4304 Lutterworth Road through woodland, for a total distance of approximately 480 metres to point "B" on the plan, situate at its eastern-most junction with the A4304 Lutterworth Road at Grid Reference 45638 28357.

The short section of Public Footpath X16 that crosses Footpath X31 in order to gain access to the A4304 Lutterworth Road (and is thus co-existent with it) shall not be stopped up.

The section of Footpath X31 to be stopped up has no recorded width.

The Order comes into force on 5th March 2022 but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from the date of this Notice, make an application to the High Court.

This Order is made by Leicestershire County Council ("the authority") under Section 118 of the Highways Act 1980 (hereinafter called "the 1980 Act") because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

Harborough District Council has been consulted as required by Section 120(2) of the 1980 Act and the District Council has consented to the making of the Order

BY THIS ORDER

- 1. The public right of way over the land situated at Parish of Misterton with Walcote and shown by a bold continuous line on the map contained in this Order and described in the Schedule hereto shall be extinguished at the expiration of 30 days from the date of confirmation of this Order.
- 2. Notwithstanding anything contained in paragraph 1 of this Order where immediately before the date on which the public right of way referred to therein is extinguished in pursuance of this Order, there is apparatus on, under or over the right of way belonging to statutory undertakers, for the purpose of carrying on

their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

3. This Order may be cited as the "Section 118 - Highways Act 1980 (Public Footpath X31, (Part) At Misterton With Walcote) Parish of Misterton with Walcote, District of Harborough, Public Path Extinguishment Order 2021."
