Your Personal Data

Who we are:

We are Harborough District Council and your privacy is important to us. We aim for full transparency on how we gather, use, and share your personal information in accordance with the General Data Protection Regulation.

This will help ensure that you are always aware of what information we collect and how we use it.

What we need

We will only collect personal data about you where it is necessary carry out task associated with the Ukrainian Refugee Scheme. This will primarily refer to the processing and sharing of information between the named parties, on Ukrainian refugees being housed in Leicestershire, for example, for the Homes for Ukraine scheme. The purpose of the data processing and sharing is to permit the County Council and partners (Districts and other lawful entities) to co-ordinate and deliver appropriate and suitable housing and accommodation offers provided by vetted sponsors, to visa-cleared applicants to the scheme fleeing the conflict in Ukraine. The data required will include: **See Appendix A**

Why we need it

The Council uses your personal information in order to meet its obligations under various UK laws:-

- Refugee Convention
- Immigration and Asylum Act 199
- Human Rights Act 1998: Articles 1,3 and 8
- The Policing Crime Act 2017
- The Crime and Disorder Act 1998
- The Police Act 1996
- Children's Act 2004/1989
- Race Relations Act as Amended 2000
- The Public Order Act 1986
- The Localism Act 2011
- The Local Government Act 2000

The processing of your information is necessary for compliance with the legal obligations contained in these Acts to facilitate a statutory obligation and provide access to Council services.

What we do with it

Your personal information will be treated as confidential but it may be shared with other Council services and partners in order to deliver the scheme as described above. Additionally, it will be used to ensure our records are accurate and up-to-date, and to improve the standard of the services we deliver. We will only use your information in ways which are permitted by the General Data Protection Regulation and the current UK Data Protection law.

We have a Data Protection regime in place to oversee the effective and secure processing of your personal data. More information on this framework can be found on our [website](#)

This authority has a duty to protect the public funds it administers, and may use information held about you for all lawful purposes, including but not limited to the prevention and detection of crime including fraud and money laundering.

The Council may also use your information for the purpose of performing any of its statutory enforcement duties. It will make any disclosures required by law and may also share your information with other bodies responsible for detecting/preventing crime including fraud or auditing/administering public funds.

There is also information about your computer hardware and software that is automatically collected by Harborough District Council. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by Harborough District Council for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Harborough District Council Web site.

The Council will also undertake to share information with the following where circumstances or law require:

- Judicial Agencies e.g. Courts
- Police
- Health Agencies
- Education Providers
- Other Local Authorities
- Immigration Service
- Government Departments e.g. HMRC, DWP, DCLG
- Safeguarding Boards
- Contractors providing housing services (e.g. plumbing, electricians, gas operatives etc.) and IT services
- Elected Members & MPs (as your representative)
- Funding Bodies

Any transfers and data sharing will take place under the provisions of an Information Sharing Agreement whether formal or ad hoc. We will not disclose your personal information to third parties for marketing purposes.

What are your rights

You have the right to:

- request a copy of your information (known as a subject access request)
- request rectification or erasure of your information,
- request a restriction on the processing of your information, and,
- object to processing of your information,
- complain to the Information Commissioner's Office about the way the Council processes your information.
- set your browser to remove or reject cookies before using Harborough District Council website

What Special Category information does HDC collect from and about you?

We collect and use different types of personal information about you, depending on your circumstances or your individual needs and requirements. This may include details of and medical and financial needs assessments which may be required in order for the Council to deliver its service to you.

Transferring information overseas

How your information is stored.

Currently all related data processing is carried out and stored with username, password and profile restricted system and network storage locations. Access to such systems is profiled to be on a role/need basis. Some bespoke systems are used and restricted in the same manner.

How long we keep your information

We will keep your information for as long as it is required by us or other regulatory bodies in order to comply with legal and regulatory requirements or for other operational reasons. Please see the Council's [Document Retention Policy](#) for further information.

Data will be shared between partners as required. (HMG, County, District, Law Enforcement or any other duly authorised body)

Sponsor data

- Name/alias
- Address
- Date of Birth

- Immigration status of the Sponsor
- Above details on individuals living in the same household as the sponsor (or a recommended sponsor)

- Age
- Sex
- Email address
- Telephone number
- Potential Family members
- Passport number (and related details)
- Address Main applicant will be staying at if not with the Sponsor
