# 1. Introduction

#### 1.1. The Witness

- 1.1.1. My name is Duncan Cartwright. I am a Managing Consultant with Atkins Limited based in their Birmingham office. I have a Master of Engineering Degree from the University of Birmingham and I am a Member of the Chartered Institute of Highways and Transportation. I have over 10 years' experience as a Transport Planner working for both the public and private sector, with significant experience in the preparation of Transport Assessments.
- 1.1.2. Atkins Limited is an international design, engineering and project management consultancy working in a wide range of sectors including infrastructure, transportation, nuclear and power, oil and gas, engineering, and design.
- 1.1.3. The Ministry of Justice (MoJ) and the National Offender Management Service (NOMS) appointed consultants to prepare the documents required for the submission of an Outline Planning Application (OPA) seeking permission for a new Prison (referred to as Gartree 2). Mace Group, (on behalf of the MoJ) appointed Atkins to produce a Transport Assessment (TA) (Core Document A10) and an Outline Travel Plan (OTP) (Core Document A11).
- 1.1.4. As Technical Lead, I was responsible for producing the analysis contained within the transportation documents produced by Atkins Limited which supported the OPA (Application Reference: 21/01600/OUT).
- 1.1.5. I have prepared my Proof of Evidence (PoE) for this appeal. I confirm that the opinions expressed are my true and professional opinions.
- 1.1.6. I appear at this Inquiry on behalf of the MoJ to give evidence on transport planning matters.

#### 1.2. Background


1.2.1. This appeal concerns the decision by Harborough District Council (HDC) to refuse planning permission for a new Category B Prison (up to 82,555 sqm GEA) within a secure perimeter fence together with access, parking, landscaping, and associated engineering works on land adjacent to HMP Gartree, Gallow Field Rd, Market Harborough, Leicestershire.

#### 1.3. Site context

1.3.1. The development site is in Leicestershire to the northwest of the town of Market Harborough. Gartree 2 is proposed to be located on land to the south of HMP Gartree. HMP Gartree is a Category B men's Prison with a capacity of approximately 700 inmates. The site location is shown on Figure 1-1 (overleaf).



Figure 1-1 - Site location plan





- 1.3.2. HMP Gartree is accessed via Welland Avenue, a private road subject to a 15mph speed limit. Welland Avenue also provides access to a number of residential properties in Gartree. It is proposed to access Gartree 2 from Welland Avenue.
- 1.3.3. Welland Avenue is accessed from the north via Gallow Field Road. The junction between Welland Avenue and Gallow Field Road is a priority-controlled T-junction, with vehicles on Welland Avenue giving way to vehicles on Gallow Field Road.
- 1.3.4. Gallow Field Road a single carriageway road which is subject to the national speed limit. Gallow Field Road provides access between the village of Foxton to the west, and the B6047 Harborough Road to the east. On the approach to Foxton Primary School from both directions, there is a school safety zone in place which restricts vehicle speeds to 20mph and is operational during the AM and PM school peaks. Gallow Field Road is subject to a 7.5 tonne weight limit restriction except for loading vehicles.
- 1.3.5. There is no pedestrian infrastructure provision located along Gallow Field Road between Welland Avenue and the B6047 Harborough Road. There is an unlit footway located to the west of Welland Avenue along the westbound side of the carriageway, which provides pedestrian access to the village of Foxton and Foxton Primary School.
- 1.3.6. Welland Avenue is accessed from the south via Foxton Road. The junction between Welland Avenue and Foxton Road is a priority-controlled T-junction, with vehicles on Welland Avenue giving way to vehicles on Foxton Road.
- 1.3.7. Foxton Road is a single carriageway road which provides access between the village of Foxton to the north and the village of Lubenham to the south. Foxton Road is subject to national speed limit between the Gallow Field Road/ Foxton Road junction and the village of Lubenham. Foxton Road is subject to a 30mph speed limit between Lubenham and the A4304. Foxton Road is subject to a 7.5 tonne weight limit restriction except for loading vehicles. There is no pedestrian infrastructure located along Foxton Road between Foxton and Lubenham.

#### 1.4. Report structure

# 2. Assessment of proposal

#### 2.1. Introduction

2.1.1. This chapter provides a summary of the transportation documents which were submitted as part of the OPA. It also provides a summary of the consultation undertaken with Leicestershire County Council (LCC), as the Local Highway Authority (LHA), during the pre-application stage. I have also provided a summary of the planning contributions (agreed with LCC and included in the statutory consultee comments) (Core Document B8).

#### 2.2. Documents Submitted

2.2.1. Table 2-1 provides a summary of the transportation documents which were submitted as part of the OPA.


#### 2.3. Transport Assessment

- 2.3.1. A TA (Core Document A10) was produced to accompany the OPA. The most recent version of the TA is dated 12 August 2021.
- 2.3.2. The purpose of the TA was to evaluate the transportation aspects of the development proposals and consider the existing highway network and sustainable transport provision within the vicinity of Gartree 2.



- 2.3.3. The TA was prepared in accordance with guidance from the Ministry of Housing, Communities & Local Government on 'Travel Plans, Transport Assessments and Statements (Published on the 6 March 2014).
- 2.3.4. The TA provided a summary of the relevant transport policy (Page 10, Chapter 2 of TA) and a review of the existing transport conditions within the vicinity of Gartree 2 (Page 14, Chapter 3 of TA). The review included an overview of the existing sustainable transport facilities, including pedestrian and cycle access, bus routes and nearby railway station facilities. A summary of the existing public transport provision is outlined on Figure 2-1.

Figure 2-1 - Existing public transport provision



- 2.3.5. The TA (Page 14, Section 3.3) included a summary of the existing traffic conditions based on traffic surveys undertaken in June 2021. The TA (Page 31, Section 7.2.1.1) also included a review of historic traffic data to validate the 2021 traffic surveys, considering the potential changes in traffic flow patterns caused by the COVID-19 pandemic.
- 2.3.6. Personal Injury Accident (PIA) data was obtained for a five-year period (2016-2020).
- 2.3.7. The TA (Page 159, Appendix D) presented a preliminary highway layout for the proposed vehicular site access (off Welland Avenue).



- 2.3.8. The TA (Page 27, Section 5.2) included vehicular trip generation to/from the site during the AM (07:00-08:00) and PM (17:00-18:00) peak hours, allowing for both staff and visitor travel.
- 2.3.9. The calculated trip generation is summarised in Table 2-2.

- 2.3.10. The calculated traffic flows during the AM and PM peak hours were distributed onto the local highway network based on 2011 Census Journey to Work data and online journey planning software.
- 2.3.11. A range of future scenarios were considered, allowing for future growth and cumulative development on the highway network including:
  - a. 2021 (baseline);
  - b. 2025 (opening year with development); and
  - c. 2025 (cumulative with development).
- 2.3.12. The forecast years were generated using the latest available data from the Department for Transport (DfT).
- 2.3.13. Junction capacity modelling was completed for nearby junctions, including:
  - a. The proposed site access junction (off Welland Avenue);
  - b. The Gallow Field Road / Foxton Road junction;
  - c. The B6047 Harborough Road / Leicester Lane / Gallow Field Road junction; and
  - d. The A4304 / Foxton Road junction.
- 2.3.14. The TA used operating/visiting times to determine the arrival and departure times of uniform staff, non-uniform staff, and visitors. This was used to determine the maximum parking accumulation. The methodology accounted for overlapping during shift changes and assumed that arrivals and departures will occur during the hour before and after the shifts starts or ends, based on evidence from other similar facilities. The parking accumulation was used to inform the parking strategy for Gartree 2.
- 2.3.15. The TA (Page 31, Section 5.4) included trip generation to/from the site for all modes during the AM (07:00-08:00) and PM (17:00-18:00) peak hours, allowing for both staff and visitor travel.
- 2.3.16. The calculated trip generation is summarised in Table 2-3.

2.3.17. The 2011 Census was interrogated to understand likely travel modes of staff and visitors. This is based on the existing modal splits from the 2011 Census which were applied to daytime staff but were amended for those working late shifts as it is considered that these staff are not likely to walk, cycle or use public transport.

#### 2.4. Outline Travel Plan

- 2.4.1. An OTP (Core Document A11) was produced to accompany the OPA. The most recent version of the OTP is dated 12 August 2021.
- 2.4.2. The purpose of the OTP was to provide a strategy for Gartree 2, including a range of outline measures to encourage travel by sustainable modes amongst staff and visitors to the Prison. The OTP is a long-term management strategy for the development that aims to minimise travel to and from the site by single occupancy car, which would be secured via condition.
- 2.4.3. The key objectives of the OTP are to:
  - a. Provide an Action Plan for the Prison to encourage sustainable and safe travel to the site, whilst reducing single occupancy car use, where possible, amongst staff and visitors; and
  - Reduce traffic generated by the development, compared to that which would be generated without the implementation of the OTP, where possible.



#### 2.4.4. The OTP outlines a range of measures including:

#### Car Parking Strategy

- a. The car parking strategy (based on the parking accumulation undertaken within the TA) provides sufficient parking spaces to ensure that Prison related parking does not overspill onto the surrounding highway network and/or car parking areas relating to other uses; and
- b. To not over provide parking to ensure that sustainable transport options are not overlooked as viable alternatives.

#### Car Sharing Strategy

- The car sharing strategy minimises single occupancy car travel to and from the site by developing a site-specific car sharing scheme to accommodate the multiple shift patterns; and
- b. To allocate 5% of the total car parking capacity for car sharing in line with BREEAM Tra02

#### **Public Transport Strategy**

- The public transport strategy encourages staff and visitors to use public transport to access the Prison by providing a public transport information system in a publicly accessible area;
- b. Providing signposting from the site to key public transport services, walking and cycling routes, and local amenities; and
- c. Investigating the possibility of providing bus 'taster tickets' for employees.

#### **Cycling Strategy**

- a. The cycling strategy encourages staff and visitors to the Prison to cycle by negotiating discounts for cycling and walking equipment with local retailers and promoting these to staff as part of the induction process;
- b. Providing secure cycle parking spaces at the new development;
- Investigating the possibility of introducing an interest free loan cycle purchase scheme for staff;
- d. Investigating the feasibility of encouraging employees to undertake adult cycle training; and
- e. Providing appropriate shower and changing facilities in accordance with BREEAM
  for use by staff. Locker facilities will also be provided so that uniformed officers can
  store their civilian clothes, personal items, and cycle equipment.

#### Single Occupancy Car Strategy

a. The single occupancy car strategy minimises the number of single occupancy car trips by encouraging the use of public transport for long distance staff trips; and



b. Encouraging remote working/ conferencing facilities for non-unformed staff to minimise the need to travel.

#### 2.5. Technical Response to Systra

- 2.5.1. HDC appointed SYSTRA to undertake a review of the Highways Advice provided by LCC in relation to the OPA for Gartree 2. The SYSTRA Technical Note (Core Document B37) stated that their review focussed on perceived local concerns in relation to the capacity of the B6047 Harborough Road / Leicester Lane / Gallow Field Road junction, and the requirement for a pedestrian crossing along the A4304 in Lubenham.
- 2.5.2. Atkins produced a Technical Addendum (Core Document A44) in response to the comments provided by SYSTRA in relation to the TA and OTP. The most recent version of the Technical Addendum is dated 18 February 2022 (Core Document A44).
- 2.5.3. I note here that no comments were made by SYSTRA regarding limited access to facilities by alternative transport modes due to the location of the development.

#### 2.6. Technical Response to E&E Consultancy Ltd

- 2.6.1. On behalf of the Lubenham Parish Council, Foxton Parish Council and Laughton and Mowsley Parish Meetings, Edwards & Edwards Consultancy Limited (E&E) carried out a high-level review of the planning application, the TA prepared by Atkins (Core Document A10), the further Technical Note produced by Atkins (Core Document A44), and the various Local Highway Authority responses and the SYSTRA Technical Note (Core Document B37).
- 2.6.2. A Technical Addendum was produced by Atkins in response to the comments provided by E&E. The most recent version of the Atkins Technical Addendum is dated 29 March 2022 (Core Document B35).
- 2.6.3. Again, I note that no comments were made by E&E regarding the accessibility of the site, or that the transport options to and from the site are unsustainable.

#### 2.7. Consultation with the Local Highway Authority

- 2.7.1. LCC, as the LHA, were consulted on the TA (Core Document A10) and OTP (Core Document A11) in advance of the OPA submission to agree the scope of our assessment. Atkins continued to engage with LCC during the Determination Period. The discussions during the Determination Period were used to discuss planning contributions with the Interim Team Manager for 'Safe & Sustainable Travel' within LCC.
- 2.7.2. Table 2-4 provides a summary of the meetings held between Atkins and LCC.

- 2.7.3. Following the consultation during the pre-application stage and the Determination Period, LCC confirmed that they had no highways objections to the OPA. In the statutory consultee comments (Core Document B8) LCC stated in their substantive response that:
  - a. The LHA Advice is that, in its view, the impacts of the development on highway safety would not be unacceptable, and when considered cumulatively with other developments, the impacts on the road network would not be severe. Based on the information provided, the development therefore does not conflict with paragraph 111 of the National Planning Policy Framework (2021), subject to the conditions and/or planning obligations outlined in this report.
- 2.7.4. Following the appointment of SYSTRA (by HDC) to undertake a review of the Highways Advice provided by LCC in relation to the OPA. HDC reconsulted with LCC and requested statutory consultee comments in relation to the report produced by SYSTRA (Core Document B37) and the Technical Response produced by Atkins (Core Document A44). In the revised statutory consultee comments (Core Document B38) LCC stated:



a. In summary, the LHA maintains its advice as set out in its observations dated 1st November 2021. The application as submitted cannot be demonstrated to result in a severe impact at the Gallow Field Road/ B6047 junction, nor can a signalised pedestrian crossing in Lubenham be justified consistent with the tests as set out in the NPPF.

#### 2.8. Agreed contributions

2.8.1. The agreed s106 contributions (relating to transport) are outlined in the statutory consultee comments issued by LCC (Core Document B8). For ease of reference the agreed contributions are summarised in Section(s) 2.9 and 2.10 below.

#### 2.9. Section 106 contributions

- 2.9.1. Construction traffic routing arrangements shall be implemented in accordance with the details included in the Gartree 2 Framework Construction Traffic Management Plan (dated 10 August 2021) prepared by Atkins and submitted to the Local Planning Authority on 20 September 2021. During the period of construction, all traffic to and from the site shall always use the agreed route.
- 2.9.2. Prior to commencement of the development a contribution of £102,898 towards improvements to the Public Right of Way (A22) linking Gallow Field Road and Swingbridge Street shall be paid to Leicestershire County Council.
- 2.9.3. Appointment of a Travel Plan Co-ordinator from commencement of development until 5 years after the occupation of the last unit. The Travel Plan Co-ordinator shall be responsible for the implementation of measures as well as monitoring and implementation of remedial measures.
- 2.9.4. Prior to first use of the development hereby permitted a Travel Plan monitoring fee of £6,000 shall be paid to Leicestershire County Council for the use of Leicestershire County Council's Travel Plan Monitoring System.

#### 2.10. Additional benefits

2.10.1. The MoJ has explored the provision of additional public transport benefits, including a financial contribution to the local bus service that serves the existing and proposed prisons.

#### 2.11. Summary

2.11.1. This chapter demonstrates that the proposed development was discussed extensively with LCC, as the LHA. The submitted reports and findings were thoroughly reviewed by the County Council who confirmed that they had no highways objections to the OPA. This position remained unchanged following the review by SYSTRA.



# 3. Reasons for Refusal and Objections

#### 3.1. Reason for refusal

3.1.1. The OPA was refused by the Harborough District Council Planning Committee (HDCPC), based on the issues set out in the Decision Notice (Core Document A75). For ease of reference the reason for refusal relevant to my Proof is outlined below.

#### Reason for Refusal 1

3.1.2. The proposed development is unsustainable by virtue of its location and by virtue of its size, scale and design would have a harmful impact on the character and appearance of the countryside and Area of Separation. The benefits associated with the proposed development would not outweigh this harm and the proposal is therefore contrary to Harborough Local Plan policies GD1 & GD3 and Lubenham Neighbourhood Plan policies LNP01, LNP16 and LNP19.

#### 3.2. Scope of my proof

- 3.2.1. The scope of my Proof is to demonstrate that appropriate opportunities to promote sustainable transport modes can be or have been taken up, given the type of development and its location.
- 3.2.2. I am specifically responding to the Council's assertion that the proposed development is unsustainable by virtue of its location. Ms Hulse and Ms Machin will respond on the matters of size, scale, and design.

### 3.3. Objections

- 3.3.1. I am aware that numerous parties have also raised formal objections to the proposals, including Gartree Action (GA) who have received Rule 6 Status.
- 3.3.2. Matters raised by the Rule 6 Party include:
  - a. Sustainable transport; and
  - b. Trip generation and alternative transport modes.
- 3.3.3. Therefore, in addition to responding to Reason for Refusal 1, I will also provide a response to these specific objections (please refer to Chapter 6).



# 4. Relevant policy, standards, and guidance

#### 4.1. Policy documents

#### National Planning Policy Framework

- 4.1.1. The NPPF (Core Document H1) sets out the Government's planning policies for England and how these are expected to be applied. The purpose of the planning system is to contribute to the achievement of sustainable development in three mutually dependent dimensions: economic, social, and environmental. It is recognised that transport policies have an important role to play in facilitating sustainable development.
- 4.1.2. The following parts of the NPPF are material to my evidence:
  - a. Paragraph 105;
  - b. paragraph 110, a);
  - c. paragraph 111; and
  - d. Annex 2: Glossary.
- 4.1.3. It should be noted that sustainable transport is a defined term within the NPPF (refer to Annex 2 within the NPPF 2021). The NPPF defines sustainable transport as:

Any efficient, safe and accessible means of transport with overall low impact on the environment, including walking and cycling, ultra-low and zero emission vehicles, car sharing and public transport.

- 4.1.4. The NPPF states that when assessing specific applications for development, it should be ensured that appropriate opportunities to promote sustainable transport modes can be or have been taken up, given the type of development and its location (refer to Paragraph 110 (a) within the NPPF 2021).
- 4.1.5. NPPF again notes that sustainable transport opportunities vary depending on location in Paragraph 105:

However, opportunities to maximise sustainable transport solutions will vary between urban and rural areas, and this should be taken into account in both plan-making and decision-making.

#### Leicestershire Local Transport Plan 3

- 4.1.6. Leicestershire's third Local Transport Plan (LTP3) sets out how the LHA will seek to ensure that transport continues to play an important role in helping Leicestershire to continue to be a prosperous, safe, and attractive County. The following parts of the Leicestershire LTP3 are material to my evidence:
  - a. Chapter 5 (Supporting the economy and population growth), specifically 5(b);
  - b. Chapter 6 (Encouraging active and sustainable travel), specifically 1(e), 4(c), 4(d); and



c. Chapter 7 (Improving the connectivity and accessibility of our transport system), specifically 5b).

#### Harborough Local Plan

- 4.1.7. The Harborough Local Plan provides an important strategy for Harborough District. It plays a significant role in delivering sustainable development in appropriate locations and in helping to protect the countryside, important green spaces, and the built and natural heritage from inappropriate or insensitive development, thus enhancing the quality of life for people and communities. The following parts of the Harborough Local Plan are material to my evidence:
  - a. Paragraph 11.2(1); and
  - b. Paragraph 11.2(2b), 11.2(2c), 11.2(2d), and 11.2(2f).

#### Lubenham Neighbourhood Plan

- 4.1.8. The Lubenham Neighbourhood Plan has been developed by the Parish Council as a local planning document that covers the whole Parish including Gartree, Bramfield and Greenacres, as well as taking into consideration the Strategic Development Area (SDA) to the north of Harborough. The following parts of the Lubenham Neighbourhood Plan are material to my evidence:
  - a. Policy LNP16, Paragraph 5.47(b), 5.47(d), 5.47(e), and 5.47(f).



# Matters raised by Harborough District Council

#### 5.1. Introduction

5.1.1. My evidence demonstrates that appropriate opportunities to promote sustainable transport modes can be or have been taken up, given the type of development and its location.

#### 5.2. HDC objection

5.2.1. The SoC issued by HDC (Core Document C4) included one specific objection to the OPA referring to the sustainability of Gartree 2:

The Council's evidence will confirm that the ability to access the site by any mode other than private car is limited. This will make reference to the limited expectation to reach the site by walking, cycling and public transport, despite proposed infrastructure upgrades as part of this proposal. Amongst other things, this results from the countryside location, house prices in the localised area and operational constraints of public transport and operational hours/shift patterns of the facility.

5.2.2. As per Section 4.1, sustainable transport is a defined term within the NPPF and when assessing specific applications for development, it should be ensured that appropriate opportunities to promote sustainable transport modes can be or have been taken up, given the type of development and its location. The following paragraphs outline the sustainable transport opportunities (existing and proposed) available to staff and visitors in relation to Gartree 2.

#### EV and car sharing spaces

5.2.3. Section 6.3 (Page 32) within the TA outlines the proposals to provide 53 3kw Electric Vehicle (EV) charging stations and 27 car sharing spaces as part of the development (in line with BREEAM Tra 02). EV charging stations and car sharing spaces are both defined within the NPPF as sustainable modes of transport.

#### Walking (PRoW)


5.2.4. During the consultation undertaken with LCC, the MoJ agreed to provide a contribution of £102,898 to improve the existing Public Right of Way (A22) linking Gallow Field Road and Swingbridge Street (refer to Paragraph(s) 2.9.2 within this Proof). It is considered that this contribution would improve the existing pedestrian links within the vicinity of the site.



#### Cycling

- 5.2.5. Figure 3-3 within the TA (Page 18, Core Document A10) demonstrates that it is possible to cycle to the villages of Foxton and Lubenham within 10 minutes, and the town of Market Harborough within 20 minutes.
- 5.2.6. The multi-modal trip generation outlined in the TA (Page 31, Table 5-6) assumes that there would be 14 people who would cycle to Gartree 2 daily. This number does not consider the impact of the measures contained within the OTP.
- 5.2.7. Figure 5-1 outlines the existing cycle infrastructure between Gartree and Market Harborough. The map demonstrates that there are designated on-road cycle routes along sections of Leicester Road, whilst there is also a designated off-road route using National Cycle Network (NCN) Route 6 along the Grand Union Canal.
- 5.2.8. Whilst it is recognised that staff and/or visitors cycling between Gartree and Market Harborough would be required to cycle along sections of carriageway without any designated cycle infrastructure, cycling is a genuine choice for staff and/or visitors travelling between Gartree and Market Harborough.

Figure 5-1 – Existing cycle infrastructure (Gartree to Market Harborough)






#### Bus

- 5.2.9. The TA (Page 19, Section 3.4.3.1) states that the nearest bus stop to Gartree 2 is located along Gallow Field Road to the north of the site. The bus stop is located within a 10-minute walk of Gartree 2 and is served by the number 44 service.
- 5.2.10. Figure 5-2 provides an overview of the number 44 service between Foxton and Market Harborough. It should be noted that the number 44 service operates a one-way loop from the B6047 Harborough Road/Gallow Field Road/ Leicester Lane junction around Foxton and Gartree. This means that the average journey time from Gartree to Market Harborough Railway Station is 16 minutes and the average journey time from Market Harborough Railway Station to Gartree is 34 minutes. In addition, the first bus to leave the Railway Station in the morning does not arrive at Gartree until 07:57. However it does provide a genuine choice for staff and/or visitors travelling between Gartree and Market Harborough via public transport.
- 5.2.11. Further information regarding the number 44 service, and how it aligns with the proposed shift patterns and visiting periods is provided in Section 5.3. The full bus timetable is included in Appendix A.

#### Rail

5.2.12. The TA (Page 20, Section 3.4.3.2) notes that the nearest Railway Station is Market Harborough. The Station is served by regular train services operated by East Midlands Railway to London St Pancras International, Nottingham, Leicester, Kettering, and Bedford. The train timetable is included in Appendix B.

#### Public transport improvements

- 5.2.13. As outlined within Table 2.3 (of this PoE), Atkins undertook consultation with the Interim Team Manager for 'Safe & Sustainable Travel' within LCC during the Determination Period. Atkins confirmed that the OTP (Core Document A11) proposes a 5% reduction in single occupancy car trips and asked LCC to confirm if the existing Public Transport network could be improved to help facilitate the anticipated modal shift.
- 5.2.14. LCC confirmed that they would actively work with the MoJ to agree any public transport improvements, but reiterated that LCC, as the LHA, do not consider public transport improvements to be necessary and reasonable to mitigate the impact of the development.
- 5.2.15. Over and above the agreed contributions outlined within Section 2.9 (of this PoE), the MoJ has sought to provide additional benefit, including a financial contribution to the local bus service which serves the existing and proposed Prisons.
- 5.2.16. During the consultation with the Interim Team Manager for 'Safe & Sustainable Travel', the potential to re-route the existing bus service along the southern section of Welland Avenue was discussed, in addition to improving the service frequency and/or hours of operation. Although nothing has been agreed to date, the MoJ remain committed to exploring further public transport benefits.

#### **Outline Travel Plan**

5.2.17. As part of the OPA, the MoJ also submitted an OTP (Core Document A11) which included a range of measures to encourage travel by sustainable modes amongst staff and visitors to the Prison. The MoJ has also agreed to provide a s106 contribution to enable LCC to implement and review the OTP for a period of up to 5 years (refer to Paragraph 2.9.4 within this Proof).

#### 5.3. Sustainable transport opportunities

- 5.3.1. The TA (Page 27, Section 5.2.1.1) assessed the vehicular impact of Gartree 2 using a scenario which made assumptions about the mode share for the proposed Prison. This scenario was developed to ensure a robust highway assessment, and as such underemphasised the potential for sustainable travel.
- 5.3.2. It was acknowledged in the TA (Page 23, Section 3.7) that there are limited opportunities for staff and visitors to walk to Gartree 2. However, the TA did identify sustainable transport options including cycling (Page 17, Section 3.4.2) and public transport (Page 18, Section 3.4.3).



- 5.3.3. The following Sections provide a summary of the sustainable transport opportunities available to staff and visitors, considering the proposed shift patterns and visiting periods. The sustainable transport opportunities considered are based on the following assumptions:
  - a. Trips between Gartree and Market Harborough have been considered;
  - b. Sustainable transport opportunities have only been identified as genuine if staff and/or visitors are able to arrive and depart via the same mode of transport; and
  - c. The latest timetable information available has been used.

#### **Uniformed Staff**

5.3.4. Table 5-1 provides a summary of the sustainable transport opportunities available to uniformed staff, considering the proposed shift patterns.

5.3.5. Table 5-1 demonstrates that there are a genuine range of choices of sustainable transport options for all the shifts. Whilst it is acknowledged that the proposed shift times do not align with the existing bus service provision, those members of uniformed staff can still arrive for their shift using alternative modes of sustainable transport including cycling, rail, car sharing or Electric Vehicles.

#### Non-Uniformed Staff

5.3.6. Table 5-2 provides a summary of the sustainable transport opportunities available to non-uniformed staff, considering the proposed shift patterns.

5.3.7. Table 5-2 demonstrates that it is possible for non-uniformed staff to arrive for their shift using a genuine range of sustainable transport opportunities in line with the NPPF (2021).



#### **Visitors**

5.3.8. Table 5-3 provides a summary of the sustainable transport opportunities available to visitors, considering the proposed visiting periods.

5.3.9. Table 5-3 demonstrates that visitors can travel to Gartree 2 using a genuine range of sustainable transport opportunities in line with the NPPF (2021). Whilst it is acknowledged that the evening visiting period does not align with the existing bus service provision, those visitors can still arrive using alternative modes of sustainable transport including cycling, rail, or Electric Vehicles.

#### **Summary**

- 5.3.10. In addition to the EV charging stations and car sharing spaces, the cycling and public transport options represent a viable opportunity for sustainable transport modes to access the site.
- 5.3.11. I consider that appropriate opportunities to promote sustainable transport have been taken up (or proposed), given the type of development and its location, in line with the NPPF (Paragraph 110 (a.)) and that the site would be accessible by a genuine choice of sustainable transport modes in line with the NPPF (Paragraph 105).



# 6. Matters raised by Gartree Action

#### 6.1. Introduction

6.1.1. This section considers the matters raised by GA as discussed in Section 3.2.

#### 6.2. GA

6.2.1. The SoC issued by GA (Core Document C5) included one specific objection to the OPA referring to the sustainability of Gartree 2. Specifically, the SoC refers to the existing sustainable transport options:

On accessibility, GA's evidence will seek to complement the Council's position by demonstrating that the transport options to and from this rural location are unsustainable. GA will draw upon the Appellant's trip generation data to contend that virtually all trips to and from the site will be made by car, many from some distance, and that this will impact local residents.GA will also demonstrate that alternative transport modes are not practical and that the rural bus service is not a suitable solution for commuters or visitors. GA will demonstrate that MoJ's offer of £500,000 to support a bus service, and other sustainable transport 'solutions', are wholly inadequate. The unsuitability of the site from a sustainable transport perspective cannot be mitigated.

- 6.2.2. Please refer to Section 5.3 regarding the matter of the practicality of alternative transport modes.
- 6.2.3. Regarding the bus contribution, it is highlighted that LCC, as the LHA, do not consider public transport improvements to be necessary and reasonable to mitigate the impact of the development. The proposed contribution discussed with LCC is to (so far as possible) facilitate access to high quality public transport, and provide appropriate facilities that encourage public transport use, in line with NPPF Paragraph 112.(a).
- 6.2.4. However, as per Paragraph 5.2.16, no public transport contributions have been agreed with LCC, although the MoJ remain committed to exploring further public transport benefits.



# 7. Summary and conclusion

## 7.1. Summary of findings

- 7.1.1. This Appeal Statement has sought to demonstrate that:
  - a. LCC, as the LHA has confirmed that they have no highways objections to the OPA;
  - b. Appropriate opportunities to promote sustainable transport can be or have been taken up, given the type of development and its location, and that the site would be accessible by a genuine choice of sustainable transport modes in line with the NPPF; and
  - c. The MoJ remain committed to exploring further public transport benefits.

#### 7.2. Conclusion

7.2.1. In relation to transport and highways, the planning application was refused on the single ground (RfR1) that:

The proposed development is unsustainable by virtue of its location and by virtue of its size, scale and design would have a harmful impact on the character and appearance of the countryside and Area of Separation. The benefits associated with the proposed development would not outweigh this harm and the proposal is therefore contrary to Harborough Local Plan policies GD1 & GD3 and Lubenham Neighbourhood Plan policies LNP01, LNP16 and LNP19.

- 7.2.2. Based on the evidence contained within my proof, it is my professional opinion that appropriate opportunities to promote sustainable transport modes can be or have been taken up, given the type of development and its location. Therefore, the proposals comply fully with the NPPF in terms of sustainable transport given its location.
- 7.2.3. Furthermore, it is my professional opinion that the development would not have an unacceptable impact on highway safety and the residual cumulative impacts on the road network would not be severe, so does not meet the criteria for refusal on highways grounds as set out in Paragraph 111 of the National Planning Policy Framework.

#### Travel assistance

We provide a free service for passengers who require travel assistance getting on and off our trains and around our stations. All of our trains have wheelchair spaces and universal toilets with baby changing facilities.

To make sure that our staff are ready to help you and understand your specific needs, we recommend requesting assistance at least two hours before you travel. Our trains and stations can be very busy, and we encourage customers to arrive in good time in order to be assisted. We recommend arriving at the station 20 minutes prior to your departure time. However, please seek advice about the station you are travelling from to ensure that you have enough time to get to the train.

To request assistance, download the Passenger Assistance by Transreport app (via Android/IOS store), at eastmidlandsrailway.co.uk/trainsstations/assisted-travel, by calling 08000 11 33 23 or by using our TextDirect service on 18001 08000 11 33 23. For more information, our Making Rail Accessible leaflet is available at our manned stations or on our website.



#### Car parking

Car parking is available at many of our stations, with Off Peak rates offered after 10:00 on weekdays and all day at weekends and on bank holidays. We also have drop off areas and short stay parking areas at some stations. For more information, visit the National Rail website: nationalrail.co.uk/stations.



#### **Bicycles**

Most of our EMR Intercity trains have two bicycle spaces, which can be reserved in advance and are free of charge. Visit eastmidlandsrailway.co.uk/cycles or call us on 03457 125 678. There are currently no dedicated cycle spaces on EMR Connect services, but you can travel with folding bikes at any time. Please ensure these are stored safely. Full-size bicycles are not permitted on EMR Connect services arriving into London before 10:00 or services leaving London between 16:00 and 19:00.

If you travel with a bike at other times of the day or at weekends, these must be stored in the vestibule area and you must stay with your bike throughout the journey.

The majority of our stations offer free cycle storage, and we have secure cycle hub areas at Sheffield, Leicester, Nottingham, Kettering, Loughborough and Lincoln.



#### WiFi

WiFi is free on all EMR Intercity and Connect services to/from London St Pancras International for passengers throughout the train.



#### Ticket information and Penalty Fares

A Penalty Fare is issued to passengers who travel without a valid ticket you must purchase a valid ticket before boarding the train.

Tickets can also be purchased on the day at ticket offices or from ticket machines at our stations. We accept cash and most major credit/debit cards. Only if the ticket office is closed, the ticket machines are out of order or the ticket you require is not available from the ticket machine are you able to buy your ticket on-board, and not be issued a Penalty Fare.

For more information on Penalty Fares, visit **eastmidlandsrailway.co.uk/penaltyfares**. Our Penalty Fares leaflet is also available at our manned stations.

Passengers with Smartcards should ensure that they carry this with them on every journey, as failure to do so will result in a Penalty Fare being issued.



#### **Digital Ticketing**

**Smartcard** - The EMR Smartcard makes travel quicker and easier by keeping all your train tickets securely in one place. Tap your Smartcard onto the reader at our ticket machines, platform validators or ticket gates. If you're at the station, you can buy tickets from the ticket office or ticket machines and load them straight onto your Smartcard.

**m-ticket** - We now offer mobile train tickets (m-tickets) on selected routes. An m-ticket is simply a train ticket stored on your mobile device: that could be an Anytime, Off-Peak, Super Off-Peak or Advance ticket.

**e-ticket** - An e-ticket, or electronic ticket, is a train ticket sent to you as a PDF file. You can print it out yourself, or simply display it on your mobile device.

**Flexi Season -** A Flexi Season ticket allows eight days of travel in 28 days – any time between two stations, offering flexibility and savings when working fewer days in the office.

In line with the terms and conditions, all electronic tickets must be downloaded and activated prior to travel.

#### **Delay Repay**

You can claim compensation if you are delayed by 15 minutes or more by visiting our website at **eastmidlandsrailway.co.uk/delay** or by filling in a form that is available at our manned stations. You can now set up an account, making it quicker and easier to claim.



#### Short platforms

Please be aware that if you are travelling to Long Eaton or Beeston, that these stations have shorter platforms than many of our trains. Not all carriage doors will open at these stations, so listen out for on-board announcements about where to leave the train.



#### **Right Time Railway**

So we can get you there on time we run a Right Time Railway. For safety, and to make sure trains leave on time, train doors will be closed 40 seconds before the scheduled departure time. At London St Pancras International train doors will be closed two minutes before the departure time.



#### Stay safe on your journey

- Please ensure you always stand clear from the edge of the platforms at our stations. Many of our stations have a yellow line on the floor that you should stand behind. This means there is less crowding around the doors as other passengers alight, fewer safety hazards and enables our train to depart on time.
- Always arrive at the station with plenty of time to board our trains and find your seat. Sometimes, our trains are formed of multiple units with no walkway in between, meaning that if you board at the wrong end, you may not be able to access your reserved seat.
- Many of our stations have lifts installed, and these should be used if you have multiple bags or heavy cases. Please speak to a member of staff if you require help, or see page 4 of this timetable for more information on booking travel assistance.
- Always apply the brakes to stationary wheelchairs and pushchairs when on our stations, as some platforms have a slight slope on them.
- We use station tannoy systems to announce important information relating to our services, such as platform alterations or the position of First Class on the train. Please be mindful of this if listening to music or talking on the phone whilst waiting for your train.



#### Lost property

If you leave an item on one of our trains, aim to contact us as soon as possible by visiting **eastmidlandsrailway. co.uk/lostproperty** and fill out the online form. We will continually search our database, and may get in touch to find out more information about your item, if required. If we find it, we'll contact you to let you know where it is and won't charge for storage or collection.

#### Local connections

Many of our stations offer extensive onward travel connections. See below for details of some of these.



#### Bus

A combined train and bus ticket is provided by PlusBus and available at several of our stations. These can be purchased from the PlusBus website, at **plusbus.info**, or from ticket machines at our stations. For information about which stations are served by PlusBus, please visit their website. #### Tram

If you're travelling to or from Nottingham, NET tram tickets are available at the railway station. The closest tram stop can be accessed from the centre footbridge of Nottingham station.

Supertram operates a wide tram network across Sheffield and Rotherham. Tickets can be purchased on-board, and there is a tram stop at the rear exit of Sheffield station.



#### Taxi

With Cab&Go, you can easily book and pay upfront for a taxi to take you to or collect you from East Midlands Railway stations. This service is available at **eastmidlandsrailway.co.uk/cab-and-go** and can be booked up to two hours before you arrive.

Many of our stations also have dedicated taxi ranks. Visit **traintaxi.co.uk** for more information about which taxi companies serve each station.



#### **Eurostar connections**

Eurostar services to locations including Paris, Brussels and Amsterdam are available from London St Pancras International. Visit **eurostar.com** for more information.



#### **Airport connections**

Several stations on our EMR Intercity route have simple connections to international airports. At Luton Airport Parkway, the Railink will take you from the station to London Luton Airport for a small fee. If you're travelling to East Midlands Airport, a Skylink bus runs from Derby, Long Eaton and Nottingham stations throughout the day.



#### First Class

First Class is available on EMR Intercity services to and from London St Pancras International.

Our First Class carriages have bigger seats, more legroom, power sockets at every seat and free WiFi. From Monday to Saturday, our on-board hosts will deliver an atseat service to you offering a selection of complimentary hot and cold drinks and snacks.

There are no First Class facilities on our trains on our EMR Connect route. Passengers wanting to take advantage of our First Class offering should change services at Kettering to board our EMR Intercity trains.

At the time of going to print, our First Class lounges are currently unavailable at our stations.

#### **Catering in Standard Class**

At the time of going to print, our Standard Class catering offering is still suspended, following the pandemic. For longer journeys, we would advise bringing your own food and drink for your journey.



#### Cleaning

Our on-board hosts on our EMR Intercity services ensure our trains are kept clean in both First and Standard Class; including the tables, seats and touchpoints around the train. Our team of cleaners thoroughly clean our trains overnight when they are not in use.



#### Seat reservations

Seats on our EMR Intercity services can be reserved up until 23:59 on the day before you are due to travel. A seat is reserved automatically when booking an advance ticket for a specific train, but can be done by calling 03457 125 678 if you have one of our more flexible tickets. If you have a paper ticket, you will need both your ticket and seat reservation with you.



#### Luggage

You can bring up to three items of luggage on-board our trains, which can include two larger items and one smaller bag. We have luggage racks throughout our trains, which should be used for large items only, whilst overhead storage space is available for smaller bags. Please ensure you only bring luggage you can carry yourself.

If you have a large number of cases or particularly large items, such as sports equipment, our partners at Carry My Luggage can transport your luggage straight to your destination. For a 15% discount, visit **carrymyluggage.com** and select EMR.






