### **Neighbourhood Forum Application - Consultation**

Harborough District Council has received a valid application to designate the **Little Bowden Neighbourhood Forum (2022 to 2027)**. The purpose of a neighbourhood forum is to act as the representative body who undertake neighbourhood planning. A neighbourhood forum has to consist of a minimum of 21 individuals and be open to those who live or work in the area.

In accordance with the Neighbourhood Planning (General) Regulations 2012 (as amended) should the designation be made no other organisation or body may be designated for that neighbourhood area until that designation expires or is withdrawn.

A decision on whether to formally designate the aforementioned neighbourhood forum will be made by the Portfolio Holder for Planning after the **6 February 2023**.

## **Neighbourhood Planning**

Neighbourhood planning gives communities direct power to develop a shared vision for their neighbourhood and shape the development and growth of their local area. They are able to choose where they want new homes, shops and offices to be built, have their say on what those new buildings should look like and what infrastructure should be provided, and grant planning permission for the new buildings they want to see go ahead. Neighbourhood planning provides a powerful set of tools for local people to plan for the types of development to meet their community's needs and where the ambition of the neighbourhood is aligned with the strategic needs and priorities of the wider local area.

Communities are able to produce a statutory 'neighbourhood plan' to be used by the Local Planning Authority when determining planning applications, but also grant 'permitted development' rights for certain types of new development. The first stage in the process for Little Bowden Neighbourhood Forum is to apply to designate a neighbourhood area (currently being advertised by HDC), and establishing a representative body – the neighbourhood forum – to carry out neighbourhood planning.
