LCC in its representation states in respect of this site "RESERVE SITE; Land north of the A47, east of Houghton (Figure 6-5) – half of the site is within MSA/MCA which is not mentioned in the assessments" and "Any allocation and forthcoming application/s would need to be accompanied by an assessment of the potential mineral resource adjacent and within the allocation in line with Policy M11 of the Leicestershire Minerals and Waste Local Plan".
